CONCERNS RELATED TO THE INCREASED USE OF ILLEGAL DRUGS BY STUDENTS

Mr. Kerry Laberge, seconded from the principalship of the PACE Outreach School, joined the meeting at 3:49 p.m. and was welcomed by Chairman Poyser. Dr. Phillips noted that two weeks ago several conversations and a meeting with a number of principals and vice-principals from junior and

senior high schools led to the request that Mr. Laberge assume a lead role in providing direction on how Battle River Regional Division #31 can provide assistance to school administrators in dealing with students who are using illegal drugs. The Advisory Committee consists of 2-4 principals, the school resource office from the City of Camrose, a Trustee and the Superintendent of Schools, as well as other resource personnel from within the Division, who will assist Mr. Laberge in developing a direction and focus for this work.

Mr. Laberge provided information to the Trustees, noting that he has seen an increase in the use of illegal drugs (narcotics) and that the target population is younger (junior high school level). Mr. Laberge has also noted the increase in damaging choices youth in the community are making with respect to using these drugs. Mr. Laberge has provided to school administrators information with respect to the symptoms of drug usage and will work with, and try to determine what will work with, junior high school students. The working committee will receive advice from the advisory committee to provide a made-in-Battle River Regional Division #31 solution. Mr. Laberge will work with a coordinated community committee and other school communities in Battle River Regional Division #31 with respect to this concern.

Trustees were informed that Mr. Laberge has been seconded for 4-6 weeks for the Committee work, and that Mr. Kevin Martin has been appointed a temporary principal at the PACE Outreach School.

Trustee Fitzmaurice-Johnson volunteered to be the Trustee representative on the Advisory Committee.

Trustee Throndson left the meeting at 4:18 p.m.

ENROLMENTS

Dr. Phillips reviewed the current enrolments in Battle River Regional Division #31 by wards, a comparison of pupil-teacher ratios for September 2001 and September 2002, and noted schools that are at, or below, the critical minimum enrolment (CME) as defined in policy FL 'School/Program Closure'. Schools/programs whose enrolments are at, or fall below, the CME, as of September 30, 2002, are: the elementary program at the Alliance School, the junior high school program at the Edberg School, the elementary and junior high school program at the Heisler School, and the elementary and junior high school program at the Strome School. Dr. Phillips noted that, with the exception of the Heisler School, the enrolments at the above-noted schools has not declined during the past several years.
