## **Busing Eligibility Changes**

The Board of Trustees discussed the significant impact of Alberta Education's new transportation eligibility changes, which will increase the minimum distance for busing eligibility from 1 km to 1.6 km for students in Grades 1 to 6, effective for the 2025-26 school year. This change will affect a substantial number of BRSD students, requiring adjustments to transportation planning and operations.

## Joint Use and Planning Agreement

The Board has approved the Joint Use and Planning Agreement (JUPA) between BRSD and the Village of Hay Lakes, and between BRSD and the Village of Heisler.

As the Education Act (S 53.1) requires, school divisions must enter into a JUPA under section 670.1 of the Municipal Government Act with each municipality within which the school division operates.

### **Budget Assumptions**

To support 2025-26 budget decisions, the Board will continue to review budget assumptions.

Budget assumptions include estimates and facts that support the development of the division's budget based on the best information available when the 2025-26 budget is prepared.

### **Community Engagement**

As part of the Board's Community Engagement Plan, members are meeting with the Killam Town Council on Thurs., Feb. 20, 2025.

The discussion will be focused on the Board's political advocacy plan, including their strategic plan, capital priorities, and other priorities. This meeting reflects the Board's ongoing commitment to collaboration with community stakeholders to advance initiatives.
